Page 3-lines 2 through 11 Delete entirely and insert:

"Notwithstanding any other provision of this article, residential property may be exempt from taxation to preserve home ownership in Wyoming for the elderly and infirm. The legislature may provide for residential property to be exempt from taxation in whole or in part as it determines necessary for purposes of this section."

Page 3-lines 16 through 23 Delete entirely.

Page 4-lines 1 through 3 Delete entirely and insert:

"The adoption of this amendment to the Wyoming Constitution would authorize the legislature to provide for a property tax exemption as it determines necessary to preserve home ownership for the elderly and infirm.". DOCKSTADER
