A BILL

for

1 AN ACT relating to state legislative districts; providing  
2 definitions; providing a plan for state legislative  
3 districts based upon the 2020 census; providing for  
4 election of the senate; and providing for an effective  
5 date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

8

9 **Section 1.** W.S. 28-2-116 through 28-2-119 are  
10 repealed and recreated as 28-2-116 through 28-2-119 to  
11 read:

12

13 **28-2-116. Legislative districts generally;**  
14 **definitions.**

15

1 (a) As used in W.S. 28-2-116 through 28-2-119:

2

3 (i) "Census block" means a geographic area of  
4 the state of Wyoming specified by the United States bureau  
5 of the census in accordance with the 2020 decennial census  
6 and identified uniquely by census block number;

7

8 (ii) "Voter tabulation district" or "VTD" means  
9 a geographic area of the state of Wyoming specified by the  
10 United States bureau of the census in accordance with the  
11 2020 decennial census and identified by Wyoming VTD name  
12 and number;

13

14 (iii) "This act" means W.S. 28-2-116 through  
15 28-2-119.

16

17 (b) As used in W.S. 28-2-118 and 28-2-119 unless the  
18 context otherwise requires:

19

20 (i) "Blocks" designates the entire census block  
21 as numbered by the United States bureau of the census for  
22 the 2020 decennial census within the named VTD and county  
23 is a part of the legislative district;

2           (ii) "(Name of) County" designates either that  
3 the entire named Wyoming county is within the legislative  
4 district or that a portion of the named Wyoming county as  
5 specified is within the legislative district;

6

7           (iii) "District (number)" designates the  
8 legislative district number assigned to a house or senate  
9 legislative district from which a legislator is elected  
10 under this act;

11

12           (iv) "VTD" designates either that the entire  
13 voter tabulation district as named by the United States  
14 bureau of the census for the 2020 decennial census within  
15 the named county is a part of the legislative district or  
16 that a portion of the named voter tabulation district  
17 within the named county as specified is a part of the  
18 legislative district.

19

20           (c) W.S. 28-2-118 creates legislative districts for  
21 the Wyoming senate and W.S. 28-2-119 creates legislative  
22 districts for the Wyoming house of representatives.

23

1           (d) The secretary of state shall maintain and make  
2 available for public inspection in a hardcopy or electronic  
3 format, or both, during regular business hours:

4  
5           (i) The United States P.L. 94-171 data for the  
6 2020 decennial census received by that office from the  
7 United States bureau of the census; and

8  
9           (ii) The list and geographic description of the  
10 legislative districts for the Wyoming senate as provided in  
11 W.S. 28-2-118(b) and enacted into law and the list and  
12 geographic description of the legislative districts for the  
13 Wyoming house of representatives as printed in "Attachment  
14 A" referenced in W.S. 28-2-119(b) and enacted into law.

15  
16           **28-2-117. Effective date of changes in legislative**  
17 **districts; election of holdover senators.**

18  
19           (a) Changes in all legislative districts are  
20 effective for the 2022 general election cycle and the  
21 sixty-seventh legislature.

22

1           (b) Members for senate districts designated as  
2 odd-numbered districts in W.S. 28-2-118(b) shall be elected  
3 for a term of four (4) years at the 2022 general election.  
4 As provided in subsection (c) of this section, no election  
5 shall be held in 2022 for senate districts designated as  
6 even-numbered districts in W.S. 28-2-118(b) for which  
7 members were elected at the 2020 general election and  
8 nothing in this act shall affect the terms of those  
9 members. Members for senate districts designated as  
10 even-numbered districts in W.S. 28-2-118(b), shall be  
11 elected for a term of four (4) years at the 2024 general  
12 election.

13

14           (c) A member elected in the 2020 general election for  
15 a senate district designated as an even-numbered district  
16 in W.S. 28-2-118(b) who has been removed from the district  
17 as a result of district boundary changes made by this act  
18 may continue to serve the remainder of the member's term  
19 for the district from which the member was elected.

20

21           (d) Nothing in this act otherwise affects the terms  
22 of members of the sixty-sixth legislature.

1           **28-2-118. Senate legislative districts; list of**  
2 **nested house districts formed to create senate districts.**

3

4           (a) Subsection (b) of this section creates  
5 legislative districts for the Wyoming senate consisting of  
6 the numbered legislative districts contained therein.  
7 There shall be one (1) senator elected from each  
8 legislative district as specified in subsection (b) of this  
9 section. Senate districts shall consist of the entirety of  
10 the geographic area of the two (2) house districts listed  
11 in subsection (b) of this section for each senate district  
12 and as fully described in "Attachment A."

13

14           (b) Senate districts shall consist of the entirety of  
15 the geographic area of the following two (2) house  
16 districts per senate district:

17

18                   (i) Senate District 1 - House Districts 1 and  
19 52;

20

21                   (ii) Senate District 2 - House Districts 6 and  
22 62;

1           (iii) Senate District 3 - House Districts 2 and  
2 5;

4           (iv) Senate Districts 4 - House Districts 7 and  
5 8;

7           (v) Senate District 5 - House Districts 12 and  
8 42;

9

10          (vi) Senate District 6 - House Districts 43 and  
11 61;

12

13          (vii) Senate District 7 - House Districts 9 and  
14 41;

15

16          (viii) Senate District 8 - House Districts 11  
17 and 44;

18

19          (ix) Senate District 9 - House Districts 13 and  
20 45;

21

22          (x) Senate District 10 - House Districts 14 and  
23 46;

2                   (xi) Senate District 11 - House Districts 15 and  
3 47;

5                   (xii) Senate District 12 - House Districts 17  
6 and 48;

8                   (xiii) Senate District 13 - House Districts 39

20 **28-2-119. House legislative districts; lists of**  
21 **census blocks for split voter tabulation districts in the**  
22 **house of representatives.**

23

1           (a) Subsection (b) of this section creates  
2 legislative districts for the Wyoming house of  
3 representatives consisting of the numbered legislative  
4 districts contained therein. There shall be one (1)  
5 representative elected from each legislative district as  
6 specified in subsection (b) of this section. The area  
7 within a county, voter tabulation district or census block  
8 as provided in paragraphs (i) through (iii) of this  
9 subsection is determined using the United States bureau of  
10 the census topologically integrated geographic encoding and  
11 referencing data base (TIGER®). Each numbered legislative  
12 district in subsection (b) of this section consists of the  
13 combined geographic area within the:

14

15           (i) Entire specified county, if the county alone  
16 is listed with no geographic subdivision listed below it;

17

18           (ii) Voter tabulation district, if any are  
19 listed below the specified county; and

20

21           (iii) Census block, if any are listed below the  
22 specified voter tabulation district. A census block listed

1 below a voter tabulation district indicates a split voter  
2 tabulation district.

6 **Section 2.** This act is effective immediately upon  
7 completion of all acts necessary for a bill to become law  
8 as provided by Article 4, Section 8 of the Wyoming  
9 Constitution.
