A BILL

for

1 AN ACT relating to public funds; authorizing investment of
2 the Wyoming game and fish fund as specified; making a
3 conforming amendment; and providing for an effective date.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

7 **Section 1.** W.S. 9-4-715(p)(v) and 23-1-501(b) are
8 amended to read:

10 **9-4-715. Permissible investments.**

11

12 (p) There is created the pool A investment account.
13 The state treasurer, or his designee, which shall be
14 registered under the Investment Advisor's Act of 1940 as
15 amended if required to be registered by the terms of that
16 act as amended, pursuant to subsections (c) and (d) of this

1 section and after consultation with the state agency or
2 agencies receiving or administering investment earnings
3 from the monies invested in the pool A investment account,
4 may invest monies comprising the pool A investment account
5 in equities including stocks of corporations in accordance
6 with subsections (a) and (c) through (e) of this section
7 and W.S. 9-4-716. The state loan and investment board, in
8 consultation with the state agency or agencies receiving or
9 administering investment earnings from the monies invested
10 in the pool A investment account, shall annually review the
11 state investment policy statements for the investment pool
12 created by this subsection as required under W.S. 9-4-716.
13 Monies in the following funds shall be invested in the pool
14 A investment account:

16 (v) The trust account within the Wyoming game
17 and fish fund created by W.S. 23-1-501(f) and any other
18 monies designated by the Wyoming game and fish commission
19 for investment in the Pool A investment account from within
20 the Wyoming game and fish fund created by W.S. 23-1-501;

22 **23-1-501. Game and fish fund.**

1 (b) All ~~income~~revenue received by the commission or
2 department shall be deposited in the state treasury and
3 credited to the Wyoming game and fish fund. Monies in the
4 fund designated by the commission for investment in the
5 Pool A investment account shall be invested pursuant to
6 W.S. 9-4-715(p). The commission may establish accounts
7 within the fund to carry out the purposes of this act, in
8 addition to those accounts established by law. The Wyoming
9 game and fish fund shall be expended as the commission may
10 direct to carry out the purposes of this act and for no
11 other purpose, except that the legislature may appropriate
12 so much thereof as necessary for expenses of any authorized
13 legislative committee to study matters relating to the
14 commission or department. Expenditures from the Wyoming
15 game and fish fund shall be made only by warrant issued by
16 the state auditor upon vouchers signed by the director and
17 chief fiscal officer, or other persons designated by the
18 commission to sign in their absence, substantiated and
19 approved as provided by law.

21 **Section 2.** This act is effective July 1, 2022.
