10 (a) There is continuously appropriated not more  
11 than fifteen million dollars (\$15,000,000.00) at any one  
12 (1) time, except as otherwise provided in this section  
13 from the legislative stabilization reserve account to  
14 the University of Wyoming student housing account  
15 created by this act. Funds from this appropriation may  
16 only be expended by the trustees of the university for  
17 initial costs of construction for phase 1 and phase 2 of  
18 the student housing project. All unexpended, unobligated  
19 funds appropriated under this subsection shall revert to  
20 the legislative stabilization reserve account on March  
21 24, 2023.

22  
23 (b) There is appropriated thirty-four million  
24 dollars (\$34,000,000.00) from the legislative  
25 stabilization reserve account to the University of  
26 Wyoming student housing account created by this act.  
27 Funds from this appropriation may only be expended by  
28 the trustees of the University of Wyoming for the payment  
29 of principal and interest on any outstanding securities  
30 issued by the university as of March 1, 2019. All  
31 unexpended, unobligated funds appropriated under this  
32 subsection shall revert to the legislative stabilization  
33 reserve account on March 24, 2023."

19 (a) Notwithstanding any other provision of law, the  
20 University of Wyoming shall not expend any funds from any source  
21 on the construction of the west stands of the University of Wyoming  
22 war memorial stadium or on the University of Wyoming natatorium to  
23 replace or expand Corbett pool without further express legislative  
24 authorization, provided that the University of Wyoming may expend  
25 appropriated funds for the routine maintenance, emergency  
26 maintenance, planning and design of the west stands of the  
27 University of Wyoming war memorial stadium or on the University of  
28 Wyoming Corbett pool in accordance with the requirements of any  
29 appropriations.

30  
31 (b) Not later than July 10, 2023, and again not later than  
32 the tenth calendar day after the end of each calendar quarter, the  
33 University of Wyoming shall report to the joint appropriations  
34 committee on all of the following:

35  
36 (i) The construction budget and timelines for the  
37 projects identified in this section and the University of Wyoming  
38 student housing project;

40 (ii) The status and progress of the projects identified  
41 in this section and the University of Wyoming student housing  
42 project;

44 (iii) Any change orders completed for the projects  
45 identified in this section and the University of Wyoming student  
46 housing project;

1           (iv) The status of fundraising efforts to raise matching  
2 funds, and the source of any matching funds received, for purposes  
3 of the appropriations to the University of Wyoming in 2022 Wyoming  
4 Session Laws Chapter 49, Section 4, Section 067."
