This appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation on June 30, 2024 shall revert as provided by law. If the federal funds are withheld, it is the intent of the legislature that the department of health include funding for this purpose in the department's next biennial budget request."
