AN ACT relating to trade and commerce; requiring the office of homeland security to establish a reporting system for concerns regarding critical infrastructure as specified; authorizing the governor to specify countries and companies as threats to critical infrastructure; providing definitions; specifying applicability; providing an appropriation; authorizing positions; and providing for an effective date.
