Page 2-after line 8 Insert:

"39-11-111. Distribution.

(a) All revenue received and collected by the department shall be transferred to the state treasurer, who shall credit the proper accounts.

(b) Contingent upon available funds, any distributee of property tax revenue may apply to the department of revenue for reimbursement of reduced property tax revenue caused by the taxable value determined by W.S. 39-11-101(a)(xvii)(C) being set below nine and one-half percent (9.5%). The reimbursement amount shall be determined by calculating the difference in revenue generated by a nine and one-half percent (9.5%) taxable value compared to the revenue generated by the actual assessment rate established by W.S. 39-11-101(a)(xvii)(C) when it is less than nine and one-half percent (9.5%). If there are insufficient funds appropriated for this purpose the reimbursement to each property tax distributee shall be reduced on a pro rata basis as determined by the department of revenue."

Page 2-after line 20 Insert and renumber as necessary:

"39-13-111. Distribution.

(e) Contingent upon available funds, any distributee of property tax revenue may apply to the department of revenue for reimbursement of reduced property tax revenue caused by the taxable value determined by W.S. 39-13-103(b)(iii)(C) being set below nine and one-half percent (9.5%). The reimbursement amount shall be determined by calculating the difference in revenue generated by a nine and one-half percent (9.5%) taxable value compared to the revenue generated by the actual assessment rate established by W.S. 39-13-103(b)(iii)(C) when it is less than nine and one-half percent (9.5%). If there are insufficient funds appropriated for this purpose the reimbursement

to each property tax distributee shall be reduced on a pro rata basis as determined by the department of revenue.

Section 2. There is appropriated eighty-four million dollars (\$84,000,000.00) from the general fund to the department of revenue for purposes of reimbursing property tax distributees for reduced property tax revenue as provided in W.S. 39-11-111(b) and 39-13-111(e). This appropriation shall be for the period beginning with the effective date of this act and ending on June 30, 2024. These funds shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2024. It is the intent of the legislature that this appropriation be included in the department's standard budget for the immediately succeeding fiscal biennium."
