This appropriation shall not be transferred or expended for any other purpose and any unexpended, unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2026. To the extent funds are not expended or obligated by July 1, 2024 the office of the governor may expend the funds for the purposes enumerated in sections 2, 3 and 4."
