Shed antlers and horns conservation stamp.

## A BILL

for

1 AN ACT relating to game and fish; providing that any shed

2 antlers and horns on public land are the property of the

- 3 state; requiring nonresidents to obtain a conservation
- 4 stamp to collect shed antlers and horns on public land;
- 5 providing exceptions specifying fees; requiring rulemaking;
- 6 and providing for an effective date.

8 Be It Enacted by the Legislature of the State of Wyoming:

- 10 **Section 1.** W.S. 23-1-103 and 23-1-302(a)(xxxi) are
- 11 amended to read:

13 23-1-103. Ownership of wildlife; purpose of

1

14 provisions.

15

- 1 For the purpose of this act, all wildlife in Wyoming is the
- 2 property of the state, including shed antlers or horns
- 3 located on public lands. It is the purpose of this act and
- 4 the policy of the state to provide an adequate and flexible
- 5 system for control, propagation, management, protection and
- 6 regulation of all Wyoming wildlife. There shall be no
- 7 private ownership of live animals classified in this act as
- 8 big or trophy game animals or of any wolf or wolf hybrid.

10 23-1-302. Powers and duties.

11

12 (a) The commission is directed and empowered:

13

14 (xxxi) To regulate and control the collection of shed antlers and horns of big game animals for the purpose 15 16 of minimizing the harassment or disturbance of big game 17 populations on public lands west of Interstate 90 from the line to Buffalo 18 Wyoming-Montana state and west of 19 Interstate 25 from Buffalo to the Wyoming-Colorado state 20 line any time during the year, subject to the provisions 21 for bighorn sheep horns in W.S. 23-3-117. Pursuant to this paragraph during the period beginning 6:00 a.m. on May 1 22 23 and ending June 30, the commission shall require

1	nonresidents	to	obtain	a	conservation	stamp	for	the

- 2 collection of big game animal shed antlers and horns on
- 3 public lands. A conservation stamp shall not be required
- 4 for residents of Wyoming, any person under fifteen (15)
- 5 years of age or for the collection of shed antlers and
- 6 horns by or on behalf of a nonprofit organization. The
- 7 commission shall adopt rules necessary to issue a
- 8 conservation stamp under this paragraph;

9

- 10 **Section 2.** The game and fish commission shall
- 11 promulgate all rules necessary to implement the provisions
- 12 of this act.

13

- 14 **Section 3**. This act is effective immediately upon
- 15 completion of all acts necessary for a bill to become law
- 16 as provided by Article 4, Section 8 of the Wyoming
- 17 Constitution.
