A BILL

for

1 AN ACT relating to worker's compensation; amending the
2 extrahazardous industries codes to conform with changes to
3 the North American Industry Classification System manual;
4 repealing a related law; and providing for an effective
5 date.

7 *Be It Enacted by the Legislature of the State of Wyoming:*

9 **Section 1.** W.S. 27-14-108(a)(ii)(F)(I), (G)(II)(1)a.,
10 (III)(1)a., b., (IV), (J)(I), (S)(I)(1)c. and by creating a
11 new subdivision d. is amended to read:

13 **27-14-108. Extrahazardous industries, employments,**
