W.S. 35-2-914 is created to read: 7 8 9 35-2-914. Visitation rights. 10 11 (a) A health care facility that provides twenty-four (24) hour per day care, including a hospice, hospital, 12 13 intermediate care facility, nursing care facility, 14 psychiatric care facility, residential rehabilitation facility or assisted living facility shall allow visitation 15

1 for a person receiving care in that facility. The 2 visitation required under this section shall not apply to 3 persons involuntarily detained under W.S. 25-10-109 or 4 25-10-110 or adults who have been convicted of a crime and 5 are in the custody of the state or a local jurisdiction.

(b) A health care facility subject to subsection (a) 7 of this section may impose and enforce restrictions on 8 9 visitation that limit the number or age of visitors, limit 10 the location or time of visitation, require protective equipment or impose requirements otherwise required under 11 12 W.S. 35-1-240 or by the centers for Medicaid and Medicare services, the centers for disease control or the joint 13 accreditation of 14 commission on the healthcare 15 organizations. Visitation may be further restricted or 16 limited under this section when the health care facility 17 determines a restriction or limitation is necessary due to a court order, violent or disruptive behavior or reasonable 18 19 suspicion of abuse or neglect against a person receiving 20 care in the facility. A health care facility shall provide 21 a written copy of its visitation policy to every person 22 admitted to the facility or to that person's representative and shall visibly post in the facility one (1) copy of the 23
