Description of appropriations:

The 0900 series expenditures will be used for contract services to complete Level I Reconnaissance Studies and Level II Feasibility Studies for new development, rehabilitation and dam and reservoir projects. In addition, the 0600 series expenditures include a grant to the University of Wyoming to administer and conduct water research. These funds are augmented with funds from the U.S. Geological Survey and the University of Wyoming. Finally, the amounts appropriated and transferred from the General Fund will be used to fund a newly authorized position as well as consulting services for the Upper Colorado River Basin.

The bill also amends 2022 Wyoming Session Laws, Chapter 51, Section 2, Section 037. In this amendment, \$7,129,414 is appropriated from the General Fund to the State Engineer's Office, Board of Control and (\$7,129,414) is de-appropriated from Water Development Account I to the State Engineer's Office, Board of Control. These amounts are based on the original appropriation from Water Development Account I to the State Engineer's Office, before the processing of the B-11 from the July pay increase.
