1 In addition to the acknowledgment of instruments in the 2 manner and form otherwise authorized by law, persons who 3 perform service in the uniformed services or 4 dependents, wherever located, may acknowledge the instruments before any commissioned officer who performs 5 service in the uniformed services with the rank of second 6 lieutenant or higher in the army, air force, or marine 7 8 corps or space force, or ensign or higher in the navy or 9 coast guard. The instrument is not invalid for failure to 10 state therein the place of execution or acknowledgment.
