## A BILL

for

1 AN ACT relating to game and fish; allowing for the use of

2 artificial light including thermal or infrared imaging or

3 other imaging outside the normal visible light spectrum

4 while hunting predatory animals at night; making conforming

5 amendments; requiring rulemaking; and providing for

6 effective dates.

8 Be It Enacted by the Legislature of the State of Wyoming:

10 **Section 1.** W.S. 23-3-103(a) and 23-3-306(b)(intro),

11 (ii), by creating a new paragraph (iii) and by creating a

12 new subsection (h) are amended to read:

- 1 23-3-103. Taking predatory animals, predacious birds
- 2 and trophy animals; taking furbearing animals and game
- 3 birds without license prohibited.

4

- 5 (a) Predatory animals and predacious birds may be
- 6 taken without a license in any manner and at any time
- 7 except as provided by W.S. 23-2-303(d) and (e), 23-3-112,
- 8 23-3-304(b), 23-3-305, 23-3-306(b) and 23-3-307. The
- 9 department shall report annually to the Wyoming department
- 10 of agriculture the number of predatory animals and
- 11 predacious birds taken by the department's animal damage
- 12 control agents, and include in the report the area where
- 13 taken and the control method used.

- 23-3-306. Use of aircraft, automobiles, motorized and
- 16 snow vehicles and artificial light for hunting or fishing
- 17 prohibited; exceptions; penalties.

- 19 (b) No person shall take any wildlife with the aid of
- 20 or by using any artificial light or lighting device except
- 21 as otherwise provided in subsections (f) and (g) through
- 22 (h) of this section and except that predators predatory
- 23 animals may be taken with the aid of an artificial light or

1 lighting device including thermal or infrared imaging or 2 other light imaging specified by rule of the commission by: 3 4 (ii) A landowner, resident manager, or person with the landowner's or a resident manager's written 5 permission to take predators predatory animals, on land 6 7 under the landowner's control for the protection of his 8 property; -9 10 (iii) Any person taking a predatory animal on 11 public land. 12 13 (h) The commission shall establish by rule specifications for the taking of predatory animals with the 14 use of artificial light or lighting devices including 15 16 thermal or infrared imaging or other light imaging 17 specified by the commission. 18 Section 2. 19 The and fish commission shall game 20 promulgate all rules necessary to implement the provisions of this act. 21
