2	For the purpose of this act, all wildlife in Wyoming is the
3	property of the state, including shed antlers or horns
4	located on public lands. It is the purpose of this act and
5	the policy of the state to provide an adequate and flexible
6	system for control, propagation, management, protection and
7	regulation of all Wyoming wildlife. There shall be no
8	private ownership of live animals classified in this act as
9	big or trophy game animals or of any wolf or wolf hybrid.
