1 2 This article shall be known and may be cited as the 3 "Wyoming Housing Trust Fund." 4 42-2-602. Wyoming housing trust fund; purpose. 5 б 7 (a) The legislature finds and declares that: 8 9 (i) There is in this state a critical shortage 10 of adequate, affordable housing; 11 12 (ii) It is in the public interest of the citizens of this state to facilitate the provision of 13 adequate, affordable housing in order to promote the 14 economic welfare of the state and its residents by 15 16 increasing employment, stimulating economic activity, 17 augmenting sources of tax revenue, fostering economic stability and improving the state's economy; 18 19 20 (iii) It is the purpose of this article to promote and continue economic development by providing 21 adequate housing necessary to create additional economic 22 benefit to the state; 23 HB0132

1 2 (iv) This article constitutes a valid public 3 purpose of primary benefit to all citizens of the state of 4 Wyoming. 5 42-2-603. Wyoming housing trust fund created; corpus б 7 inviolate; investment by state treasurer. 8 9 (a) The Wyoming housing trust fund is created. The 10 fund shall consist of those funds designated to the fund by 11 law and all monies collected from federal grants and other 12 contributions, grants, gifts, bequests and donations to the housing trust fund. 13 14 (b) The monies deposited into the Wyoming housing 15 16 trust fund established pursuant to this section 17 intended to be inviolate and constitute a permanent or perpetual trust fund. The state treasurer shall invest the 18 19 fund as authorized by law and in a manner to obtain the 20 hiqhest net return possible consistent 21 preservation of the corpus. Any earnings from investment of the corpus of the housing trust fund shall be credited by 22

the state treasurer into the Wyoming housing trust fund
 earnings account which is hereby created.

4 Section 2. During the 2023 interim, the joint appropriations committee shall conduct a study examining 5 the creation of a Wyoming housing trust fund program that 6 shall distribute earnings from the trust fund to affordable 7 8 housing projects. Pursuant to the study, the joint 9 appropriations committee shall bring any necessary or 10 advantageous legislation for the 2024 Budget Session. Such 11 legislation shall comply with article 3, section 36 and 12 article 16, section 6 of the Wyoming constitution and require that the attorney general certify the legality of 13 the housing trust fund program and its 14 method for 15 distribution of earnings.

17 **Section 3.** There is appropriated fifteen million dollars (\$15,000,000.00) from the general fund to 18 the 19 Wyoming housing trust fund for the purpose of funding the 20 Wyoming housing trust fund as created by this act. This appropriation shall not be transferred or expended for any 21 other purpose. Notwithstanding W.S. 9-2-1008, 9-2-1012(e) 22 and 9-4-207, this appropriation shall remain in effect and 23

1 not lapse or revert at the end of the fiscal period except

4 Section 4. This act is effective July 1, 2023.
