## for

1 AN ACT relating to game and fish; modifying the provisions 2 of elk, deer, antelope, bighorn sheep, mountain goat, 3 moose, grizzly bear and wild bison hunting licenses issued 4 to nonresident applicants; increasing nonresident license 5 fees to hunt elk, deer, antelope, bighorn sheep, mountain 6 goat, moose, grizzly bear and wild bison; and providing for 7 an effective date.

9 Be It Enacted by the Legislature of the State of Wyoming: 10

Section 1. W.S. 23-2-101(f)(i) through (iii), (j)(xxiii), (xxv), (xxvii) and (xxix) and 23-2-107(e) are amended to read:

5 (f) Forty percent (40%) of available nonresident elk licenses, forty percent (40%) of available nonresident deer 6 licenses and forty percent (40%) of available nonresident 7 antelope licenses for any one (1) calendar year shall as 8 9 established by the commission, be offered to nonresident 10 applicants upon receipt of the fee prescribed by this 11 Seventy-five (75) of the nonresident deer subsection. 12 licenses set aside pursuant to this subsection shall be used for a national bow hunt for deer. The licenses 13 authorized by this subsection shall be offered by drawing 14 to nonresident applicants prior to the drawing for the 15 16 remaining nonresident licenses issued. The licenses offered 17 under this subsection shall be issued in a manner prescribed by rules and regulations promulgated by the 18 19 commission. Nothing in this subsection shall prohibit any 20 unsuccessful applicant for a nonresident license pursuant 21 to this subsection from submitting an application for any licenses remaining after the drawing during the calendar 22 23 year in which the application under this subsection was
