2 (i) Accept gifts, grants and donations to 3 further the department's objectives, including gifts, 4 grants or donations made in the name of the department; 5 б (ii) Organize and manage accounts for local nonprofit partners or other organizations to benefit a 7 8 specific department project or initiative; 9 10 (iii) Create and fund positions and execute 11 contracts to accomplish department projects or initiatives. 12 No public funds shall be expended for this purpose. 13 14 (d) The department shall not be liable for any acts or omissions of any official nonprofit partner. No debts, 15 16 bonds, notes or other obligations incurred by any official 17 nonprofit partner shall constitute an indebtedness or obligation of the state of Wyoming nor shall any act of any 18 19 official nonprofit partner constitute or result in the 20 creation of an indebtedness of the state. 21
