Department to supply registration 14 certificates, plates and stickers; removable windshield 15 placards.

1 (d) As used in this section: 2 3 4 (iii) "Special license plate" means a license plate that displays the international symbol of access: 5 б 7 (B) The plate shall consist of the arabic 8 numerals designating the county in which issued at the 9 left, followed by the bucking horse and rider emblem and a 10 distinctive combination of up to three (3) numbers and 11 letters as determined by the department, followed by the 12 international symbol of access. After the county number on 13 the left-hand end, the license plate may also contain a distinctive symbol or letters, as determined by the 14 15 department, indicating the vehicle type. A special license 16 plate issued for a motorcycle or multipurpose vehicle shall 17 not be less than three (3) inches wide and six (6) inches long and shall contain the international symbol of access 18 19 and appropriate identification which may be in lieu of the 20 bucking horse and rider emblem. The motorcycle and 21 multipurpose vehicle license plate may also contain a distinctive symbol or letters, as determined by the 22 23 department, indicating the vehicle type.
