10 (a) All monies received by the state of Wyoming from the  
11 secretary of the treasury of the United States under the provisions  
12 of the act of congress of February 25, 1920 (41 Stat. 437, 450; 30  
13 U.S.C. 181, 191), as amended, or from lessees or authorized  
14 mine operators and all monies received by the state from its sale  
15 of production from federal mineral leases subject to the act of  
16 congress of February 25, 1920 (41 Stat. 437, 450; 30 U.S.C. 181,  
17 191) as amended, except as provided by subsection (b) of this  
18 section, shall be deposited into an account and the first two  
19 hundred million dollars (\$200,000,000.00) of revenues received in  
20 any fiscal year shall be distributed by the state treasurer as  
21 provided in this subsection. One percent (1%) of these revenues  
22 shall be credited to the general fund as an administrative fee,  
23 and the remainder shall be distributed as follows:

25 (ii) Subject to paragraph (xiii), forty-seven and one-  
26 half percent (47.5%) to the public school foundation program  
27 account subject to allocations under W.S. 9-4-605;

29 (xiii) For fiscal year 2026, the first ten million  
30 dollars (\$10,000,000.00) that would otherwise be distributed to  
31 the public school foundation program account under paragraph (ii)  
32 of this subsection shall be distributed to the Wyoming education  
33 savings accounts expenditure account subject to the terms of W.S.  
34 21-2-903(b), and any amount in excess of ten million dollars  
35 (\$10,000,000.00) shall be deposited to the public school  
36 foundation program account subject to allocations under W.S. 9-4-  
37 605;".
