8 and by creating a new paragraph (xiii) is amended to read:

10 **9-4-601. Distribution and use; funds, accounts, cities and**
11 **towns benefited; exception for bonus payments.**

13 (a) All monies received by the state of Wyoming from the
14 secretary of the treasury of the United States under the provisions
15 of the act of congress of February 25, 1920 (41 Stat. 437, 450; 30
16 U.S.C. 181, 191), as amended, or from lessees or authorized
17 mine operators and all monies received by the state from its sale
18 of production from federal mineral leases subject to the act of
19 congress of February 25, 1920 (41 Stat. 437, 450; 30 U.S.C. 181,
20 191) as amended, except as provided by subsection (b) of this
21 section, shall be deposited into an account and the first two
22 hundred million dollars (\$200,000,000.00) of revenues received in
23 any fiscal year shall be distributed by the state treasurer as
24 provided in this subsection. One percent (1%) of these revenues
25 shall be credited to the general fund as an administrative fee,
26 and the remainder shall be distributed as follows:

28 (ii) Subject to paragraph (xiii), forty-seven and one-
29 half percent (47.5%) to the public school foundation program
30 account subject to allocations under W.S. 9-4-605;

32 (xiii) For fiscal year 2026, the first forty million
33 dollars (\$40,000,000.00) that would otherwise be distributed to
34 the public school foundation program account under paragraph (ii)
35 of this subsection shall be distributed to the Wyoming education
36 savings accounts expenditure account subject to the terms of W.S.
37 21-2-903(b), and any amount in excess of forty million dollars
38 (\$40,000,000.00) shall be deposited to the public school
39 foundation program account subject to allocations under W.S. 9-4-
40 605;".
