3            **"Section 3.**  
4

5            (a) There is appropriated three million four hundred eighty-  
6 three thousand dollars (\$3,483,000.00) from the general fund to  
7 the state auditor's office. From this appropriation, the state  
8 auditor shall pay or cause to be paid to the retirement account  
9 established under W.S. 9-3-407(a) up to twenty-five one hundredths  
10 percent (0.25%) for the period beginning July 1, 2024 and ending  
11 June 30, 2025 and five tenths percent (0.5%) for the period  
12 beginning July 1, 2025 and ending June 30, 2026 of the member's  
13 salary. These payments shall be used to pay a member's share of  
14 retirement contributions without any salary reduction or offset  
15 for state employees in addition to and in the same manner as  
16 provided in title 9, chapter 3, article 4 of the Wyoming statutes.  
17 The state auditor shall distribute this appropriation as follows:  
18

19            (i) Thirty-three thousand dollars (\$33,000.00) for  
20 legislative branch employer contributions;  
21

22            (ii) One hundred thirty thousand dollars (\$130,000.00)  
23 for judicial branch employer contributions;  
24

25            (iii) One million nine hundred fifty thousand dollars  
26 (\$1,950,000.00) for state executive branch employer contributions;  
27

28            (iv) Five hundred thousand dollars (\$500,000.00) for  
29 community college employer contributions;  
30

31            (v) Eight hundred seventy thousand dollars  
32 (\$870,000.00) for University of Wyoming employer contributions.  
33

34            (b) The increased employer contribution provided under this  
35 section shall cease in the month immediately succeeding the full  
36 expenditure of the appropriation provided in subsection (a) of  
37 this section.

39            (c) For purposes of this section:

40            (i) "Member" is as defined in W.S. 9-3-402(a)(vii);  
41

42            (ii) "State employees" means employees of employers  
43 defined in W.S. 9-3-402(a)(vi)(A), (Q), (R), (S) and (T) and full-  
44

1 time brand inspection contract employees authorized to participate  
2 in the state retirement system under W.S. 9-2-3207(a)(xi)(F)(IV).

4 (d) For state employees of the executive, judicial and  
5 legislative branches, University of Wyoming and community colleges  
6 whose compensation is paid from nongeneral fund sources, to the  
7 extent funds are available, there is appropriated from those  
8 accounts and funds amounts necessary to provide payment of  
9 comparable employer paid benefits as that which is distributed to  
10 employees of entities specified in this section and subject to the  
11 same distribution methodology that is applied in this section. For  
12 state employees of the executive, judicial and legislative  
13 branches, University of Wyoming and community colleges with  
14 benefits that are partially funded by general funds, general funds  
15 shall be expended for employer paid benefit increases in the same  
16 proportion as the employee's budgeted salary is paid by state  
17 general funds.

19 (e) The appropriation in subsection (a) of this section  
20 shall be reduced by one dollar (\$1.00) for each one dollar (\$1.00)  
21 appropriated up to three million four hundred eighty-three  
22 thousand dollars (\$3,483,000.00), in section 325 of 2024 House  
23 Bill 0001."
