7 "(b) Any unappropriated funds and funds reverted in
8 subsection (a) of this section are hereby reappropriated to the
9 office of the governor for the programs and purposes specified in
10 this section beginning with the effective date of this act and
11 ending December 31, 2026, subject to subsection (c) of this
12 section. Unless otherwise specifically provided in this act, the
13 conditions, terms and other requirements of this appropriation are
14 effective until December 31, 2026. The office of the governor shall
15 expend funds reappropriated under this section on programs and
16 projects for which ARPD funds may be obligated not later than
17 December 31, 2024, subject to the following conditions:

19 (i) The offset of matching funds identified from water
20 development account I and water development account II for projects
21 that qualified for ARPD funds and received or had included state
22 water development funding from water development account I or water
23 development account II. Funds to be offset under this paragraph
24 shall revert to water development account I or water development
25 account II, as appropriate, upon distribution of funds under this
26 paragraph;

28 (ii) Supplemental grant funding to any previous
29 recipient of ARPD funds from the state for projects for Health and
30 Human Services Capital Construction. Supplemental grant funding
31 provided under this paragraph shall only be for inflation related
32 costs;

34 (iii) The offset of matching funds for projects that
35 qualified for ARPD funds and received or had included local
36 matching funds for the eligible project before the effective date
37 of this act;

39 (iv) Eligible highway projects;

41 (v) The provision of ARPD funds to the state budget
42 department for any allowable administrative expenses to provide
43 assistance necessary for the receipt and expenditure of American

1 Rescue Plan Act or other federal funds, in accordance with the
2 American Rescue Plan Act and any applicable rules and guidance.

4 (c) On September 1, 2024, all unexpended, unobligated ARPD
5 funds shall be available for the office of the governor to expend
6 on projects and programs identified by the governor for which ARPD
7 funds may be obligated not later than December 31, 2024."
