AN ACT relating to the emergency expenses of government; providing definitions; providing appropriations; amending and repealing prior appropriations of COVID-19 relief funds; specifying conditions on the appropriation and expenditure of COVID-19 relief funds; amending prior conditions on the reduction and prioritization of COVID-19 relief funds; providing for the reversion of unexpended and unobligated funds; authorizing emergency government programs; authorizing rulemaking; requiring reporting; specifying applicability; providing for priority of appropriations; and providing for an effective date.

Unless otherwise specifically provided in this act, the conditions, terms and other requirements of this appropriation are effective until December 31, 2026. The office of the governor shall expend funds reappropriated under this section on programs and projects for which ARPD funds may be obligated not later than December 31, 2024, subject to the following conditions:

(i) The offset of matching funds identified from water development account I and water development account II for projects that qualified for ARPD funds and received or had included state water development funding from water development account I or water development account II. Funds to be offset under this paragraph shall revert to water development account I or water development account II, as appropriate, upon distribution of funds under this paragraph;

(ii) Supplemental grant funding to any previous recipient of ARPD funds from the state for projects for Health and Human Services Capital Construction. Supplemental grant funding provided under this paragraph shall only be for inflation related costs;

(iii) The offset of matching funds for projects that qualified for ARPD funds and received or had included local matching funds for the eligible project before the effective date of this act;

(iv) Eligible highway projects;

(v) The provision of ARPD funds to the state budget department for any allowable administrative expenses to provide assistance necessary for the receipt and expenditure of American Rescue Plan Act or other federal funds, in accordance with the American Rescue Plan Act and any applicable rules and guidance.

(c) On September 1, 2024, all unexpended, unobligated ARPD funds shall be available for the office of the governor to expend on projects and programs identified by the governor for which ARPD funds may be obligated not later than December 31, 2024."
