18 (a) The University of Wyoming board of trustees and the
19 secretary of state's office shall conduct a study regarding the
20 possibility of increasing the number of members of the University
21 of Wyoming board of trustees by seven (7) members and requiring
22 that those members be elected at a statewide general election.
23
24 (b) As part of the study required by subsection (a) of this
25 section, the University of Wyoming board of trustees and the
26 secretary of state's office shall:
27
28 (i) Determine the cost of increasing the number of
29 members of the University of Wyoming board of trustees and their
30 election at a statewide general election;

32 (ii) Determine potential costs and benefits of
33 increasing the number of members of the University of Wyoming board
34 of trustees;

36 (iii) Provide recommendations as to whether the
37 legislature shall propose a constitutional amendment to increase
38 the number of members of the University of Wyoming board of
39 trustees and provide for those members' election.

41 (c) Not later than November 1, 2025, the University of
42 Wyoming board of trustees and the secretary of state's office shall
43 report to the joint education interim committee and the joint

1 appropriations committee the findings of the study required by
2 this section.

6 (a) There is appropriated ten thousand dollars (\$10,000.00)
7 from the general fund to the University of Wyoming board of
8 trustees to conduct the study required by section 1 of this act.
9 This appropriation shall be for the period beginning with the
10 effective date of this act and ending June 30, 2026. This
11 appropriation shall not be transferred or expended for any other
12 purpose and any unexpended, unobligated funds remaining from this
13 appropriation shall revert as provided by law on June 30, 2026. It
14 is the intent of the legislature that this appropriation not be
15 included in the University of Wyoming's standard budget for the
16 immediately succeeding fiscal biennium.

18 (b) There is appropriated ten thousand dollars (\$10,000.00)
19 from the general fund to the secretary of state's office to conduct
20 the study required by section 1 of this act. This appropriation
21 shall be for the period beginning with the effective date of this
22 act and ending June 30, 2026. This appropriation shall not be
23 transferred or expended for any other purpose and any unexpended,
24 unobligated funds remaining from this appropriation shall revert
25 as provided by law on June 30, 2026. It is the intent of the
26 legislature that this appropriation not be included in the
27 secretary of state's office standard budget for the immediately
28 succeeding fiscal biennium."
