42 (a) Notwithstanding W.S. 9-2-1008 and 9-4-207, of unexpended,
43 unobligated monies in the state shooting complex account created
44 by 2023 Wyoming session laws, chapter 146, section 3, ten million

1 dollars (\$10,000,000.00) or as much thereof as is available, and
2 an additional three million dollars (\$3,000,000.00) from the
3 Wyoming tourism reserve and projects account are appropriated to
4 the department of state parks and cultural resources for the
5 development, siting and construction of roads, motorized trails,
6 parking areas, recreation vehicle and camping sites, shooting
7 bays, buildings and other facilities for the Wyoming state shooting
8 complex. Notwithstanding W.S. 9-2-1008 and 9-4-207, any
9 unexpended, unobligated funds from these appropriations shall not
10 revert and are authorized to be expended for the operation and
11 maintenance of the Wyoming state shooting complex. These
12 appropriations shall not be transferred or expended for any other
13 purpose.

15 (b) If 2025 Senate File 0001 or 2025 House Bill 0001 is
16 enacted into law, the appropriations in subsection (a) of this
17 section shall be reduced by one dollar (\$1.00) for every one dollar
18 (\$1.00) appropriated to the department of state parks and cultural
19 resources for the Wyoming state shooting complex in 2025 Senate
20 File 0001 or 2025 House Bill 0001.".
