33 1. The department of education shall maintain the total amount of direct  
34 expenditures for and grants to local school districts in support of applied  
35 agriculture and farming programs during the 2025-2026 fiscal biennium as  
36 compared to the 2023-2024 fiscal biennium. It is the intent of the legislature  
37 that any expenditures by the department of education pursuant to this footnote  
38 be documented and included in the department of education's standard budget for  
39 the immediately succeeding fiscal biennium.

1 2. Of this general fund appropriation, two hundred sixty thousand dollars  
2 (\$260,000.00) is appropriated, and of these authorized employees, one (1) full-  
3 time position is authorized for increased staffing in the finance unit.  
4

5 3. Of this general fund appropriation, thirty-three thousand four hundred  
6 seventy-six dollars (\$33,476.00) is appropriated for increased compensation and  
7 employer paid benefits for two (2) positions within the finance unit.  
8

9 4. Of this general fund appropriation, one hundred thousand dollars  
10 (\$100,000.00) is appropriated for the advancement of civics education through  
11 support of the Wyoming boys' state and Wyoming girls' state programs in the  
12 amount of twenty-five thousand dollars (\$25,000.00) annually to each program.  
13 It is the intent of the legislature that this appropriation be included in the  
14 department of education's standard budget for the immediately succeeding fiscal  
15 biennium.  
16

17 5. Of this general fund appropriation, fifty thousand dollars (\$50,000.00) is  
18 appropriated to pay for processing costs for Wyoming poultry, lamb, pork, beef  
19 or bison donated to a school district to be used in school meals. Expenditures  
20 authorized in this footnote shall be made only if an equal amount of funding  
21 has been contributed by a local school district for the processing costs of the  
22 donated Wyoming poultry, lamb, pork, beef or bison. The department shall  
23 endeavor to provide funding to as many school districts as possible under this  
24 footnote and participation in the federal school lunch program shall not be  
25 used as a limiting criterion for the distribution of these funds. To the extent  
26 all funds from this appropriation are expended, the department of education  
27 shall identify other funds appropriated in this section for continuation of the  
28 expenditures under this footnote.  
29

30 6. Of this general fund appropriation, four hundred ninety-six thousand eight  
31 dollars (\$496,008.00) is appropriated, and of these authorized employees, two  
32 (2) full-time positions are authorized for outreach for the deaf and hard of  
33 hearing unit.  
34

35 7. Of this other funds appropriation, one hundred sixty-three thousand five  
36 hundred dollars (\$163,500.00)S5 is appropriated for one (1) at-will employee  
37 contract position for the Wyoming charter school authorizing board. It is the  
38 intent of the legislature that this appropriation be included in the standard  
39 budget for the department of education for the immediately succeeding fiscal  
40 biennium. This appropriation shall not be transferred or expended for any other  
41 purpose."
