12 "(a) There is appropriated to the office of the governor one
13 hundred million dollars (\$100,000,000.00) from the legislative
14 stabilization reserve account from funds transferred to the
15 account under Section 300(j) of this act and fifty-five million
16 dollars (\$55,000,000.00) from the general fund. Except as provided
17 in subsections (b), (c) and (d) of this section, this appropriation
18 is for purposes of providing matching funds for private or federal
19 funding for research, demonstration, pilot projects or commercial
20 deployment projects related to Wyoming energy needs, including,
21 but not limited to, carbon capture and utilization, ~~and storage,~~
22 carbon dioxide transportation, industrial carbon capture, coal
23 refinery, ~~and~~ hydrogen production, transportation, storage,
24 hydrogen hub development, critical minerals, biomass, biochar,
25 hydropower, lithium, processing and separation, battery storage or
26 wind and solar energy. No funds from this appropriation shall be
