13 contingency division of the office of the governor, unit 0601, for
14 the purposes specified in section 1(a) of this act;

16 (ii) The appropriation in section 1(a)(ii) of this act
17 shall be reduced by one dollar (\$1.00) for every one dollar (\$1.00)
18 appropriated in the 2025 general session for the disaster
19 contingency unit within the homeland security division of the
