(v) "Pecuniary financial factors" means prudently determined based fiduciary decisions based on appropriate investment horizons consistent with the fund's objective and investment policies while adhering to compliance with statutory and regulatory guidance. "Pecuniary financial factors" does not include non-pecuniary financial factors or the furtherance of environmental, social, governance, political or ideological interests;".
