AN ACT relating to eminent domain; repealing the ability of entities who are not public utilities to use the right of condemnation for electric generation collector systems; providing requirements for existing easements; requiring condemners to give notice to local governing bodies before commencement of a condemnation action; specifying requirements for condemnation actions; specifying applicability; and providing for an effective date.
