". If a county clerk establishes or uses a drop box in accordance with this section, the county clerk shall ensure the drop box:

(i) Is securely fastened to the ground or a concrete slab connected to the ground;

(ii) Is secured by a lock that can only be opened by the clerk or by a person designated by the clerk;

(iii) Complies with the federal Americans with Disabilities Act of accessible as determined by the county clerk;

(iv) Is under camera surveillance twenty-four (24) hours per day, seven (7) days per week. The county clerk shall keep the recordings of the camera surveillance for the same period of time that the county clerk is required to keep the ballots in the clerk's possession.". YIN
