Page 2-after line 22 Insert:

"(iii) Shall not charge a customer-generator any fee or charge that would increase the customer-generator's minimum monthly charge to an amount greater than that of other customers of the electric utility in the same rate class as the customer-generator unless a customer-generator is operating a net metering system with a generating capacity over twenty-five (25) kilowatts and the commission approves the fee or charge;".
