The ability of a parent or legal guardian to bring a civil action on behalf of the minor shall not preclude the minor from bringing an action independently upon reaching the age of majority. This civil cause of action is independent of criminal proceedings and may be brought by the minor or the minor's parent or legal guardian regardless of whether criminal charges have been filed. A civil cause of action under this section shall not be contingent upon a conviction in a criminal case."

Page 6-after line 18 Insert:

"(h) The provisions of this section shall not apply to consensual communication between a person who is not less than eighteen (18) years of age and a minor who is not more than four (4) years younger than the person if:

- (i) The communication does not involve coercion, exploitation or manipulation of the minor; and
- (ii) The communication occurs within the context of a consensual dating or romantic relationship.". WASHUT, CHAIRMAN

- (j) This section shall not apply to a minor's spouse if a judge of a court of record in Wyoming has approved the marriage, the minor's parent or legal guardian has provided consent for the marriage, or the minor is emancipated, as specified in W.S. 20-1-102(b) through (d).".
