"Section 3. There is appropriated one hundred fifty thousand dollars (\$150,000.00) from the general fund to the secretary of state for the purpose of purchasing new voting machines and ballots for counties that do not currently utilize pen and paper ballots. Upon a showing of a need for new voting machines and ballots by a county clerk, the secretary of state shall allocate the funds for their purchase. This appropriation shall be for the period beginning with the effective date of this act and ending June 30, 2026. This appropriation shall not be transferred or expended for any other purpose and any unexpended,

unobligated funds remaining from this appropriation shall revert as provided by law on June 30, 2026. It is the intent of the legislature that this appropriation not be included in the secretary of state's standard budget for the immediately succeeding fiscal biennium.".
