AN ACT relating to professions and occupations; providing for the licensing of anesthesiologist assistants and specifying scope of practice; creating and amending definitions; providing for temporary licenses as specified; providing for the imposition of fees; providing for the suspension, restriction, revocation or nonrenewal of licenses as specified; providing for license reinstatement and reactivation; creating a criminal penalty; providing for a hearing; amending the composition of the board of medicine; requiring rulemaking; and providing for an effective date.

The board of nursing shall provide by rule for requirements and limitations on the practice by and supervision of anesthesiologist assistants including the number of anesthesiologist assistants who may be supervised concurrently, and the board of nursing shall not allow a certified registered nurse anesthetist to supervise more than two (2) anesthesiologist assistants during a shift.".
