"(m) A professional or occupational licensing board shall issue a temporary license to a military service member or military spouse after receiving a completed application under this section, but while the application is pending review by the board, if the applicant holds a relevant, active occupational or professional license in good standing from another jurisdiction for not less than three (3) consecutive years. The military service member or military spouse applicant may practice under the temporary license for a period not to exceed ninety (90) days. A board shall not charge a military service member or military spouse any fees for a temporary license under this subsection.". BROWN, L, NICHOLAS
