Page 11-line 6 After "W.S. 9-4-803(a)." insert "The treasurer of a political subdivision, municipality or special district shall not deposit public monies in a credit union unless the credit union is within ten (10) miles of the office of the treasurer and there is no bank that qualifies as a depository for public monies within ten (10) miles of the applicable treasurer's office.".
