

## HOUSE BILL NO. HB0132

Annual permits for specified commercial loads.

A BILL

for

1 AN ACT relating to motor vehicles; authorizing annual  
2 permits for hauling prefabricated buildings, panels and  
3 trusses; authorizing annual permits for hauling forest  
4 products, baled hay and combine headers; specifying permit  
5 fees; requiring rulemaking; and providing for effective  
6 dates.

8 *Be It Enacted by the Legislature of the State of Wyoming:*

10 **Section 1.** W.S. 31-18-804(a) and by creating a new  
11 subsection (w) is amended to read:

12

13 **31-18-804. Permits for and certain highways to carry,**  
14 **overweight and oversize vehicles; government vehicles.**

1           (a) The director or his authorized representative may  
2 issue permits for separate movements or extended periods of  
3 movement effective for one (1) year or for one (1) or more  
4 months, not to exceed ninety (90) days permitting hauling  
5 of forest products, baled hay or combine headers. No permit  
6 issued under this section shall be granted for any load of  
7 forest products exceeding one hundred twelve (112) inches  
8 in width or any load of baled hay or combine headers  
9 exceeding one hundred fifty (150) inches in width and  
10 fifteen (15) feet in height. No single component of the  
11 load may exceed one hundred two (102) inches in width. The  
12 fee for a single trip permit is fifteen dollars (\$15.00).  
13 The fee for an extended period permit for one (1) or more  
14 months, not to exceed ninety (90) days is fifty dollars  
15 (\$50.00) and the fee for an extended period permit for one  
16 (1) year is two hundred dollars (\$200.00).

18           (w) For movements of a vehicle meeting indivisible  
19 load requirements, the director or his authorized  
20 representative may issue permits for separate movements or  
21 extended periods of movement effective for one (1) year  
22 permitting hauling of prefabricated buildings, panels and  
23 trusses. No permit issued under this subsection shall be

1 granted for any load of prefabricated buildings, panels or  
2 trusses exceeding one hundred sixty-two (162) inches in  
3 width and fifteen (15) feet in height. The fee for a one  
4 (1) year permit under this subsection is four hundred  
5 dollars (\$400.00).

7       **Section 2.** The department of transportation shall  
8 promulgate all rules necessary to implement this act.

10       **Section 3.**

11

12       (a) Except as provided in subsection (b) of this  
13 section, this act is effective July 1, 2025.

14

15       (b) Sections 2 and 3 of this act are effective  
16 immediately upon completion of all acts necessary for a  
17 bill to become law as provided by Article 4, Section 8 of  
18 the Wyoming Constitution.
