AN ACT relating to civil procedure; amending the exemption from civil liability for providing emergency services to include mental health crises; and providing for an effective date.

Be It Enacted by the Legislature of the State of Wyoming:

**Section 1**. W.S. 1-1-120(a) and (b) is amended to read:

## 1-1-120. Persons rendering emergency assistance exempt from civil liability.

- (a) Any person licensed as a physician and surgeon under the laws of the state of Wyoming, or any other person, who in good faith renders emergency care or assistance, including assistance for a mental health crisis, without compensation at the place of an emergency, or accident or mental health crisis, is not liable for any civil damages for acts or omissions in good faith.
- organizations operating volunteer (b) Persons or ambulances or rescue vehicles supported by public private funds, staffed by unpaid volunteers, and which make no charge, or charge an incidental service or user fee, for services rendered during medical emergencies or mental health crises, and the unpaid volunteers ambulances and rescue vehicles are not liable for any civil damages for acts or omissions in good faith in furnishing emergency medical services or services during mental health crises. This immunity does not apply to acts or omissions constituting gross negligence or willful or misconduct. For purposes of this section, "unpaid volunteers means persons who either receive incidental remuneration on a per call basis or receive no more than

one thousand dollars (\$1,000.00) annually for volunteer ambulance and rescue activities, including mental health services or services provided during a suicidal intervention. The immunity provided by this subsection shall extend to a physician while serving in his capacity as medical director of any ambulance service, to hospitals and hospital employees for activities directly related to providing clinical training as part of an emergency medical service class approved by the department of health, and to students while participating in emergency medical services or mental health services training approved by the department of health. If an unpaid volunteer's, medical director's, hospital's or trainee's acts or omissions are subject to the provisions of the Wyoming Governmental Claims Act, immunity under this section is waived to the extent of the maximum liability provided under W.S. 1-39-118.
