## FISCAL NOTE

This bill contains appropriations of \$14,788,031 from WATER DEVELOPMENT ACCOUNT I to the Water Development Commission. These appropriations are effective immediately.

This bill contains appropriations of \$99,994,331 from WATER DEVELOPMENT ACCOUNT II to the Water Development Commission. These appropriations are effective immediately.

This bill contains an appropriation of \$20,000,000 from the LEGISLATIVE STABILIZATION RESERVE ACCOUNT to WATER DEVELOPMENT ACCOUNT II for the Goshen Irrigation District Tunnels 1 and 2 Rehabilitation project. This appropriation is effective immediately.

This bill contains an appropriation of \$60,000,000 from the LEGISLATIVE STABILIZATION RESERVE ACCOUNT to WATER DEVELOPMENT ACCOUNT II for the LaPrele Dam Rehabilitation project. This appropriation shall be reduced one dollar (\$1.00) for each one dollar (\$1.00) appropriated from WATER DEVELOPMENT ACCOUNT II for the project, up to \$50,000,000. The net action results in a total appropriation of \$60,000,000 (\$50,000,000 from WATER DEVELOPMENT ACCOUNT II and \$10,000,000 from the LEGISLATIVE STABILIZATION RESERVE ACCOUNT) for the LaPrele Dam Rehabilitation project. This appropriation is effective immediately.

This bill contains an appropriation reduction of (\$50,000,000) from WATER DEVELOPMENT ACCOUNT III for the Alkali Creek Reservoir project.

This bill contains a transfer of \$50,000,000 from WATER DEVELOPMENT ACCOUNT III to WATER DEVELOPMENT ACCOUNT II for the LaPrele Dam Rehabilitation project.

This bill authorizes a transfer of \$4,200,000 from WATER DEVELOPMENT I to WATER DEVELOPMENT II.

## Description of appropriations:

Most of the appropriations will be expended as 0600 series Grant & Aid Payments to project sponsors (municipalities, irrigation districts, and special districts) for the design, permit procurement, land acquisition, construction engineering and construction of new water development, water rehabilitation, and water storage projects. Funds will also be expended for weather modification cloud seeding operations in the Wind River, Sierra Madre, and Medicine Bow Mountain Ranges for the winter of calendar year 2025 and 2026. It is anticipated that these funds will be expended from the 0200 series Supportive Services Costs (\$5,000) and the 0900 series Contractual Services Costs (\$1,192,143).
