1 (a) Subject to subsection (b) of this section, in 2 lieu of a bond, the operator or its principal may deposit 3 federally insured certificates of deposit payable to the 4 Wyoming department of environmental quality, or cash, or government securities, or irrevocable letters of credit 5 issued by a bank organized to do business in the United 6 7 States, or all four (4). 8 9 (b) For noncoal mining operations that take place on 10 land that is not owned or operated by the United States or a federal agency, in lieu of a bond, the operator or the 11 operator's principal may deposit federally insured 12 certificates of deposit payable to the Wyoming department 13 of environmental quality, or cash, or government 14 securities, or irrevocable letters of credit issued by a 15 16 bank or credit union organized to do business in the United 17 States, or all four (4). 18 19 (c) Irrevocable letters of credit deposited under 20 this section shall be issued by a bank that is insured by 21 the federal deposit insurance corporation or a credit union

(e) In lieu of a bond, the operator may deposit federally insured certificates of deposit payable to the 6 Wyoming department of environmental quality, cash, 7 8 government securities, or irrevocable letters of credit issued by a bank or a credit union organized to do business 9 10 in the United States, or all four (4). Irrevocable letters 11 of credit deposited under this subsection shall be issued

by a bank that is insured by the federal deposit insurance

corporation or a credit union that is insured by the 13

national credit union administration. 14

16 Section 2. This act shall apply to irrevocable 17 letters of credit deposited under W.S. 35-11-418 and 35-11-504(e) that are issued on and after the effective 18 19 date of this act.

21 Section 3. The environmental quality council, upon recommendation by the department of environmental quality, 22 23 shall promulgate all rules necessary to implement this act.
