1 (d) After making distributions pursuant to subsections (b), (c), (f) and (j) of this 2 section, 3 distributions under subsection (e) of this section shall be made from the severance tax distribution account. The 4 amount of distributions under subsection (e) of this 5 section shall not exceed one hundred fifty-five million б dollars (\$155,000,000.00) in any fiscal year. To the extent 7 8 that distributions under subsection (e) of this section would exceed that amount in any fiscal year, except as 9 10 provided in subsections (g),  $(h)_{\overline{\tau}}$  and  $(k)_{\overline{\tau}}$  and  $(m)_{\overline{\tau}}$  of this section, the excess shall be credited: 11 12 **Section 2.** W.S. 21-13-306.1 and 39-14-801(m) are 13 repealed. 14 15 16 Section 3. 2024 Wyoming Session Laws, Chapter 118, 17 Section 314 is repealed. 18 Section 4. The school foundation program reserve 19 20 account is repealed. 21 Section 5. On the effective date of this act, all 22 funds in the school foundation program reserve account 23 2 HB0293

1 shall be transferred by the state auditor to the common 2 school permanent fund reserve account created under W.S. 3 9-4-719(f). Notwithstanding W.S. 9-4-719(f), any unexpended 4 funds that have been appropriated or obligated from the 5 school foundation program reserve account before the effective date of this act shall be paid from the common б school permanent fund reserve account. Any funds that are 7 8 directed to revert by law to the school foundation program reserve account shall revert to the common school permanent 9 fund reserve account. All accrued revenues that would 10 11 otherwise be deposited in the school foundation program 12 reserve account shall be deposited in the common school 13 permanent fund reserve account.

15 Section 6. Not later than October 31, 2026 and again 16 not later than October 31, 2027, the state auditor shall 17 report to the joint appropriations committee on the amounts 18 transferred under section 5 of this act.
