4 (c) No member of the Wyoming national guard in active state service or a state security officer shall incur any 5 personal liability, civil or criminal, by reason of acts 6 committed in the performance of his necessary duties 7 8 incident to service under orders of the governor or any lawful superior if the acts are not palpably illegal, 9 excessively violent or malicious. If any civil action is 10 11 brought against a member or state security officer by 12 reason of an act or acts committed in the performance of his necessary duties, he is entitled to legal counsel to 13 assist in his defense at state expense. Legal counsel for 14 15 such purposes may be chosen by the guardsman or state 16 security officer subject to approval by the Wyoming 17 attorney general and legal fees incurred shall be approved by either: 18

Section 3. The affirmative defense created by section 1 of this act shall be available as an affirmative defense 2 to conduct occurring on and after July 1, 2025.
