6 **Section 328.**

8 (a) As used in this section, "Wyoming state shooting complex"
9 means a facility located in Park county, near Cody, that is
10 described in the state shooting complex development and oversight
11 task force final recommendation that was submitted to the governor,
12 the joint appropriations committee and the joint travel,
13 recreation, wildlife and cultural resources interim committee,
14 dated August 8, 2024.
15

16 (b) From the unexpended, unobligated balance of the state
17 shooting complex account appropriated under 2023 Wyoming Session
18 Laws, Chapter 146, Section 3(a)(ii) and the expenditure of which
19 requires additional action of the legislature, up to two million
20 five hundred thousand dollars (\$2,500,000.00), or as much thereof
21 as is available, is hereby authorized for expenditure in accordance
22 with this section.
23

24 (c) From the unexpended, unobligated balance of the state
25 shooting complex account appropriated under 2023 Wyoming Session
26 Laws, Chapter 146, Section 3(a)(iii) and the expenditure of which
27 requires additional action of the legislature, up to two million
28 five hundred thousand dollars (\$2,500,000.00), or as much thereof
29 as is available, is hereby authorized for expenditure in accordance
30 with this section.

32 (d) Notwithstanding 2023 Wyoming Session Laws, Chapter 146,
33 Section 3(b), funds authorized for expenditure under this section
34 shall be expended, without delay and as directed by the Wyoming
35 state shooting complex joint powers board through the department
36 of state parks and cultural resources, for costs related to the

1 Wyoming state shooting complex that are described in and subject
2 to the terms of a memorandum of understanding between the Wyoming
3 state shooting complex joint powers board and the department of
4 state parks and cultural resources executed on September 3, 2025.
5

6 (e) Funds authorized for expenditure under this section shall
7 not be transferred or expended for any other purpose.
8 Notwithstanding W.S. 9-2-1008, 9-2-1012(e) and 9-4-207, the
9 authority to expend funds under this section shall remain in effect
10 and not lapse at the end of the fiscal period except upon further
11 legislative action.
12

13 (f) Any unexpended, unobligated funds remaining in the state
14 shooting complex account from appropriations under 2023 Wyoming
15 Session Laws, Chapter 146, Section 3(a) and not otherwise
16 authorized for expenditure under this section shall revert to the
17 accounts from which they were appropriated.
18

19 (g) This section is effective immediately."
