6 **Section 328.**

8 (a) There is appropriated one hundred eleven million seven
9 hundred eighty-nine thousand six hundred seventy dollars
10 (\$111,789,670.00) from the general fund to the state auditor for
11 salary adjustments of generally funded employees whose salary is
12 not prescribed by law for the fiscal period beginning July 1, 2026
13 and ending June 30, 2028, as specified in this section. From this
14 appropriation, the state auditor shall distribute the following
15 amounts:
16

17 (i) Sixty-four million one hundred ninety-one thousand
18 one hundred fifty-three dollars (\$64,191,153.00) for distribution
19 among the executive branch agencies, including statewide elected
20 officials, pursuant to subsection (b) of this section for employees
21 of the executive branch, including the Wyoming community college
22 commission but not including any agency or entity specified in
23 paragraphs (ii) through (ix) of this subsection;
24

25 (ii) Seven hundred forty-eight thousand six hundred
26 forty-two dollars (\$748,642.00) to the Wyoming business council
27 pursuant to subsection (b) of this section for employees of the
28 Wyoming business council;
29

30 (iii) Twenty-one thousand seven hundred eighty-three
31 dollars (\$21,783.00) to the commission on judicial conduct and
32 ethics pursuant to subsection (b) of this section for employees of
33 the commission on judicial conduct and ethics;
34

35 (iv) Forty-eight thousand seven hundred twenty-six
36 dollars (\$48,726.00) to the Wyoming energy authority pursuant to

1 subsection (b) of this section for employees of the Wyoming energy
2 authority;

4 (v) Twenty-seven million six hundred ninety-nine
5 thousand six hundred thirty-one dollars (\$27,699,631.00) to the
6 University of Wyoming pursuant to subsection (b) of this section
7 for employees of the University of Wyoming, the University of
8 Wyoming medical education program and school of energy resources;

9
10 (vi) Three hundred seventy-seven thousand eight hundred
11 seventy-two dollars (\$377,872.00) to the University of Wyoming
12 pursuant to subsection (b) of this section for employees of the
13 enhanced oil recovery commission;

14
15 (vii) Fourteen million five hundred eighty-five thousand
16 three hundred thirty-seven dollars (\$14,585,337.00) to the
17 community college commission to be allocated among the community
18 colleges in proportion to the state funded payroll of each college
19 relative to the total state funded payroll as submitted by the
20 colleges to the state budget department and further distributed
21 within each college pursuant to subsection (b) of this section for
22 employees of the community colleges;

23
24 (viii) Two hundred eighty-three thousand five hundred
25 ninety-eight dollars (\$283,598.00) to the community college
26 commission pursuant to subsection (b) of this section for employees
27 of Wyoming public television;

28
29 (ix) Three million eight hundred thirty-two thousand
30 nine hundred twenty-eight dollars (\$3,832,928.00) to the supreme
31 court to be further distributed pursuant to subsection (b) of this
32 section among the employees of the supreme court, district courts,
33 circuit courts and related subdivisions.

35 (b) Funds appropriated under subsection (a) of this section
36 shall be distributed to employees of entities specified in
37 paragraphs (a)(i) through (ix) of this section in accordance with
38 an occupational market analysis.

40 (c) For state executive and judicial branch employees whose
41 compensation is paid from nongeneral fund sources, to the extent
42 funds are available, there is appropriated from those accounts and
43 funds amounts necessary to provide payment of comparable salary
44 increases and employer paid benefits as that which is distributed
45 to employees of entities specified in paragraphs (a)(i) through
46 (ix) of this section and subject to the same distribution
47 methodology that is applied by the entities specified in paragraphs

1 (a)(i) through (ix) of this section, respectively. For state
2 executive and judicial branch employees whose compensation is
3 partially funded by general funds, general funds shall be expended
4 for compensation increases in the same proportion as the employee's
5 budgeted salary is paid by state general funds.

7 (d) In accordance with Section 310 of this act, it is the
8 intent of the legislature that the total appropriation in
9 subsection (a) of this section to each recipient agency be included
10 as a cumulative total of the sum of the amounts within each of the
11 recipient agencies' standard budget for the immediately succeeding
12 fiscal biennium."
