7 (a) As used in this section, "Wyoming state shooting complex"
8 means a facility located in Park county, near Cody, that is
9 described in the state shooting complex development and oversight
10 task force final recommendation that was submitted to the governor,
11 the joint appropriations committee and the joint travel,
12 recreation, wildlife and cultural resources interim committee,
13 dated August 8, 2024.
14

15 (b) From the unexpended, unobligated balance of the state
16 shooting complex account appropriated under 2023 Wyoming Session
17 Laws, Chapter 146, Section 3(a)(ii) and the expenditure of which
18 requires additional action of the legislature, up to two million
19 five hundred thousand dollars (\$2,500,000.00), or as much thereof
20 as is available, is hereby authorized for expenditure in accordance
21 with this section.
22

23 (c) From the unexpended, unobligated balance of the state
24 shooting complex account appropriated under 2023 Wyoming Session
25 Laws, Chapter 146, Section 3(a)(iii) and the expenditure of which
26 requires additional action of the legislature, up to two million
27 five hundred thousand dollars (\$2,500,000.00), or as much thereof
28 as is available, is hereby authorized for expenditure in accordance
29 with this section.

31 (d) Notwithstanding 2023 Wyoming Session Laws, Chapter 146,
32 Section 3(b), funds authorized for expenditure under this section
33 shall be expended, without delay and as directed by the Wyoming
34 state shooting complex joint powers board through the department
35 of state parks and cultural resources, for costs related to the
36 Wyoming state shooting complex that are described in and subject
37 to the terms of a memorandum of understanding between the Wyoming
38 state shooting complex joint powers board and the department of
39 state parks and cultural resources executed on September 3, 2025.

41 (e) Funds authorized for expenditure under this section shall
42 not be transferred or expended for any other purpose.
43 Notwithstanding W.S. 9-2-1008, 9-2-1012(e) and 9-4-207, the
44 authority to expend funds under this section shall remain in effect

1 and not lapse at the end of the fiscal period except upon further
2 legislative action. Funds authorized for expenditure under this
3 section shall be reduced by one dollar (\$1.00) for every one dollar
4 (\$1.00) appropriated to the state shooting complex account in 2026
5 House Bill 0001, if enacted into law.

7 (f) Any unexpended, unobligated funds remaining in the state
8 shooting complex account from appropriations under 2023 Wyoming
9 Session Laws, Chapter 146, Section 3(a) and not otherwise
10 authorized for expenditure under this section shall revert to the
11 accounts from which they were appropriated.".
