15 the business council shall, not later than April 30, 2026, provide
16 all of the following information to the joint minerals, business
17 and economic development interim committee, the governor, the
18 state budget department and the Wyoming energy authority:

20 (i) The total amount of grant funds and financial aid
21 obligated for disbursement as of April 30, 2026 but not disbursed;

23 (ii) The number of loans executed by the Wyoming
24 business council that are still outstanding as of April 30, 2026.
25 In reporting information under this paragraph, the Wyoming
26 business council shall itemize each loan by program and report the
27 recipient of each outstanding loan, the terms and conditions of
28 each outstanding loan, the repayment schedule for each loan and
29 the amount remaining to be repaid for each outstanding loan;

31 (iii) The number of bonds executed by the Wyoming
32 business council before April 30, 2026 that are still outstanding
33 as of April 30, 2026. In reporting information under this
34 paragraph, the Wyoming business council shall report each
35 outstanding bond, the terms and conditions of each outstanding

1 bond and any amount remaining to be paid or repaid for each
2 outstanding bond;

4 (iv) Agreements or contracts for grants, loans, bonds
5 and financial aid for which the state receives or will receive a
6 portion or all of the funds upon a sale of property or the project;

8 (v) All real and personal property owned or held by the
9 Wyoming business council as of April 30, 2026. Information reported
10 under this paragraph shall include the program or function for
11 which the property is owned or held;

13 (vi) Each program and function administered or operated
14 by the Wyoming business council;

16 (vii) Each set or group of funds received or managed by
17 the Wyoming business council;

19 (viii) The return on investment for each program
20 operated or administered by the Wyoming business council.
