Page 8-after line 19 Insert and renumber as necessary:

"(d) In accordance with article 16, section 6 of the Wyoming constitution, the following shall apply to all grants, loans, investments, financial aid and other expenditures administered or made by the Wyoming business council:

(i) Any grant awarded by, administered by or passed through the council shall be only for a public purpose. For purposes of this paragraph, "public purpose" means an expenditure primarily serving the public health, safety or general welfare and that results in a direct public benefit of a reasonably general character, evidenced by public ownership, public control or enforceable public-use conditions proportionate to the public funds provided;

(ii) No grant funds administered by the council shall be provided to, or for the benefit of, any private individual, association or corporation. No governmental or tribal applicant shall receive a grant under this act if any portion of the grant will be transferred, conveyed, assigned, rebated or otherwise provided to or for the benefit of a private individual, association or corporation, unless the private recipient receives the benefit solely through a repayable loan or loan guarantee that requires repayment and is documented by enforceable terms and conditions;

(iii) Any financial aid or other financial assistance under this act that directly or indirectly benefits a private individual, association or corporation shall be provided only as a repayable loan or loan guarantee and shall not be provided as a grant;

(iv) Nothing in this subsection shall be construed to alter, expand or limit any program administered under any other provision of law."

Page 14-line 14 After "article." insert "Grants under this article shall be awarded only for a public purpose as defined by W.S. 9-12-601(d) (i) and in compliance with article 16, section 6 of the Wyoming constitution. No grant under this article shall be awarded if any portion of the grant will be transferred, conveyed, assigned, rebated or otherwise provided to or for the benefit of any private individual, association or corporation unless the private recipient receives the benefit solely through a repayable loan or loan guarantee requiring repayment under enforceable terms and conditions."

(i) The public purpose or purposes that exist and will be achieved by the awarding or disbursement of grant funds to the recipient;

(ii) The consideration that the recipient will provide to benefit the state of Wyoming in exchange for the award or disbursement of grant funds."
