Trapping licenses-nonresident reciprocal licenses.

A BILL

for

1 AN ACT relating to game and fish; clarifying reciprocal
2 requirements for a nonresident trapping license; requiring
3 rulemaking; and providing for effective dates.

5 *Be It Enacted by the Legislature of the State of Wyoming:*

6

7 **Section 1.** W.S. 23-2-303(a) is amended to read:

8

9 **23-2-303. Trapping licenses; tagging; traps and**
10 **snares; penalty; confiscation; inspection; interference**
11 **with trapping.**

13 (a) Any person may, in the discretion of the
14 department upon application and the payment of the proper
15 fee, receive a license to trap any furbearing animal. The

1 department shall issue a trapping license to a nonresident
2 ~~only if his state issues licenses to Wyoming residents to~~
3 ~~trap the same species for which residents of that state may~~
4 ~~be licensed to trap in that state. Any nonresident applying~~
5 ~~for a Wyoming trapping license shall furnish all of the~~
6 ~~following are met:~~

7

8 (i) A notarized affidavit stating the
9 ~~applicant's legal address including his~~ The species applied
10 for can be lawfully trapped in the applicant's state of
11 residence; and

12

13 (ii) A copy of the most current statutes or
14 ~~rules and regulations of the applicant's state of residence~~
15 ~~which show that the state issues nonresident trapping~~
16 ~~licenses which authorize Wyoming residents to trap the same~~
17 ~~species for which residents of that~~ The applicant's state
18 ~~may be licensed to trap in that state~~ issues nonresident
19 trapping licenses that authorize Wyoming residents to trap
20 the same species that residents of that state may be
21 licensed to trap;

1 (iii) The applicant furnishes all of the
2 following to the department:

3

4 (A) A notarized affidavit stating the
5 applicant's legal address, including the applicant's state
6 of residence;

7

8 (B) A copy of the most current statutes or
9 rules and regulations of the applicant's state of residence
10 that show that the applicant's state issues nonresident
11 trapping licenses that authorize Wyoming residents to trap
12 the same species for which residents of that state may be
13 licensed to trap in that state.

14

15 **Section 2.** The game and fish department shall
16 promulgate all rules necessary to implement this act.

7 immediately upon completion of all acts necessary for a
8 bill to become law as provided by Article 4, Section 8 of
9 the Wyoming Constitution.
